BOARD OF COMMISSIONERS AND BOARD OF EQUALIZATION MEETINGS July 10, 2017

The Red Willow County Board of Commissioners and the Board of Equalization met in the Commissioners' Room in the courthouse on July 10, 2017. A notice of the meetings was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, posted on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Earl McNutt called the Board of Commissioners meeting to order with the following members present: Earl McNutt, Jacque Riener and Steve Downer. McNutt informed the public about the location of the posted Open Meetings Act.

A motion was made by Downer, seconded by Riener, to approve the agendas as presented. Roll call: Ayes: McNutt, Riener, Downer.

Chairman McNutt offered the floor for citizens' comments. No one was present.

The Board reviewed the minutes from the previous meeting, and the accounts payable claims.

A motion was made by Riener, seconded by Downer, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) accounts payable claims in the amount of \$389,411.76, 3) changes to Pledged Securities for County Treasurer. Roll call: Ayes: McNutt, Riener, Downer.

Chairman McNutt recessed the Commissioners' meeting at 9:16 a.m. for the Board of Equalization. BOARD OF EQUALIZATION MEETING:

Chairman Steve Downer called the Board of Equalization meeting to order at 9:16 a.m. with the following members present: Steve Downer, Earl McNutt and Jacque Riener. Downer informed the public about the location of the posted Open Meetings Act.

Assessor Sandra Kotschwar presented her 2017 Plan of Assessment to the Board.

Treasurer Sue Wesch presented a tax roll correction for the Tax Year 2016. A motion was made by McNutt, seconded by Riener, to approve Tax Roll Correction No. 31 which decreased the tax rolls by \$19,675.00. Roll call: Ayes: Downer, McNutt, Riener.

Chairman Downer recessed the Board of Equalization meeting at 9:25 a.m.

BOARD OF COMMISSIONERS MEETING: (Reconvened)

Chairman McNutt reconvened the Board of Commissioners meeting at 9:25 a.m.

The Board discussed options offered by Klaasmeyer & Associates Inc. regarding the administration of Hillcrest Nursing Home. Options given were either to have consulting service or management services.

At the Board's request, County department heads joined them to discuss budget issues. The discussion will be continued at the next meeting on July 17, 2017 at 9:30 a.m.

An approved zoning permit for Tom Huff and the Clerk of District Court's Monthly Revenue Report were reviewed and placed on file.

Chairman McNutt adjourned the Board of Commissioners meeting at 11:00 a.m. to July 17, 2017.

Chairman Downer reconvened the Board of Equalization meeting at 1:00 p.m. in order to hear property valuation protest hearings with the following members present: Steve Downer, Earl McNutt and Jacque Riener, and County Assessor Sandra Kotschwar. Downer informed the public about the location of the posted Open Meetings Act.

Kotschwar certified to the Board that the property record files which substantiate the calculation of the protest value are maintained in her office in electronic and paper form.

Clerk Teel had notified by mail all property owners who had filed protests and encouraged them to attend their individual hearings. Hearings were held on 10 protests. The Board visited with each protester by phone or in person for approximately fifteen minutes per protest, and Assessor Kotschwar presented her information which substantiates the calculation of the protested value.

Chairman Downer thanked each protestor for attending the hearing and explained that the Board would make their decisions on the protests before July 25th and everyone would be notified by mail. Then, if someone did not agree with the decision, they could appeal it to the Tax Equalization and Review Commission (TERC) for a filing fee of \$25.00.

The protests are on file in the County Clerk's Office for public inspection. Chairman Downer adjourned the Board of Equalization meeting at 3:45 p.m. to July 11, 2017.
