BOARD OF COMMISSIONERS AND BOARD OF EQUALIZATION MEETINGS March 12, 2018

The Red Willow County Board of Commissioners and the Board of Equalization met in the Commissioners' Room in the courthouse on March 12, 2018. A notice of the meetings was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, posted on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Earl McNutt called the Board of Commissioners meeting to order with the following members present: Earl McNutt, Steve Downer and Jacque Riener. McNutt informed the public about the location of the posted Open Meetings Act.

A motion was made by Downer, seconded by Riener, to approve the agendas as presented. Roll call: Ayes: McNutt, Downer, Riener.

Chairman McNutt offered the floor for citizens' comments. Andrea Wolfe and Cayla Richards were present.

The Board reviewed the minutes from the previous meeting, and the accounts payable claims.

A motion was made by Riener, seconded by Downer, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners meeting, 2) accounts payable claims in the amount of \$178,769.66, 3) adopt Resolution No. 1325, Book 22, Page 5, to increase County Court's petty cash to \$75.00, 4) declare three monitors, two mouses, an answering machine, and a security system surplus for the County Treasurer, 5) approve changes to Pledged Securities for County Treasurer. Roll call: Ayes: McNutt, Downer, Riener.

Chairman McNutt recessed the Commissioners' meeting at 9:15 a.m. for the Board of Equalization. BOARD OF EQUALIZATION MEETING:

Chairman Steve Downer called the Board of Equalization meeting to order at 9:15 a.m. with the following members present: Steve Downer, Jacque Riener and Earl McNutt. Downer informed the public about the location of the posted Open Meetings Act.

Treasurer Sue Wesch presented two tax roll corrections for the Tax Year 2017. A motion was made by McNutt, seconded by Riener, to approve Tax Roll Correction No. 12 which increased the tax rolls by \$1,541.50, and Tax Roll Correction No. 13 which increased the tax rolls by \$387.22. Roll call: Ayes: Downer, Riener, McNutt.

Kristi Korell, County Assessor and Phil Lyons, Deputy County Attorney, joined the Board to discuss pending litigation. A motion was made by McNutt, seconded by Riener, to enter into executive session at 9:22 a.m. Roll Call: Ayes: Downer, Riener, McNutt. A motion was made by Riener, seconded by McNutt, to come out of executive session at 9:29 a.m. Roll Call: Ayes: Downer, Riener, McNutt.

Chairman Downer adjourned the Board of Equalization meeting at 9:30 a.m.

Chairman McNutt reconvened the Board of Commissioners meeting at 9:30 a.m.

Tyson Bardsley of Miller & Associates joined the Board to present an Interlocal Cooperation Resolution and Agreement between Red Willow County, Nebraska and Frontier County, Nebraska. The Agreement pertains to the County Bridge Match Program. A motion was made by Riener, seconded by Downer, to authorize the chairman's signature on Resolution No. 1326, Book 22, Page 6 for the Interlocal Agreement between Red Willow County and Frontier County. Roll call: Ayes: McNutt, Downer, Riener.

Kristi Korell, Zoning Administrator, rejoined the Board to recommend approval of Solar Farm Amendment to the County Zoning Regulations.

A motion was made by Riener, seconded by Downer, to set March 26, 2018 at 9:30 a.m. as the date and time to hold a public hearing in regards to the recommended Solar Farm Amendment that was presented by the Zoning Administrator. Roll call: Ayes: McNutt, Downer, Riener.

Approved zoning permits for Brad Farr and Luke Schwartz and the Clerk of District Court's Monthly Revenue Report were reviewed and placed on file.
