BOARD OF COMMISSIONERS MEETING

May 13, 2019

The Red Willow County Board of Commissioners met in the Commissioners' Room in the courthouse on May 13, 2019. A notice of the meeting was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Earl McNutt called the Board of Commissioners meeting to order with the following members present: Commissioners Earl McNutt, Steve Downer and Cayla Richards. McNutt informed the public about the location of the posted Open Meetings Act.

A motion was made by Richards, seconded by McNutt, to approve the agendas as presented. Roll call: Ayes: McNutt, Downer, Richards.

Chairman McNutt offered the floor for Citizens' Comments. No one was present.

A motion was made by Richards, seconded by Downer, to approve the following items on the consent agenda with one minor correction in the minutes: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) accounts payable claims in the amount of \$539,875.36, 3) authorize Chairman's signature on Oversize Load Permit for Ward Craft Homes. Roll call: Ayes: McNutt, Downer, Richards.

Ron Nealeigh of Medical Transport Solutions joined the Board to present medical transportation insurance available to county employees. The company is out of Florida, and the insurance they provide would cover air or ground transportation costs not covered by the County's medical insurance. It would cover any out of pocket expense for an employee and their family for transporting them to a larger hospital. A motion was made by Richards, seconded by Downer, to authorize the chairman's signature on an agreement allowing Ron Nealeigh to present Medical Transport Solutions to the County employees. 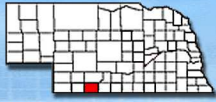
