## BOARD OF COMMISSIONERS AND BOARD OF EQUALIZATION MEETINGS February 12, 2024

The Red Willow County Board of Commissioners and the Board of Equalization met in the Commissioners' Room in the courthouse on February 12, 2024. A notice of the meetings was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Ted Gans called the Board of Commissioners meeting to order with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Gans informed the public about the location of the posted Open Meetings Act.

A motion was made by Dean, seconded by Fritsche, to approve the agendas with the removal of consent agenda item 5. Roll call: Ayes: Gans, Dean, Fritsche.

Chairman Gans offered the floor for Citizens' Comments. No one was present.

Chairman Gans recessed the Commissioners' meeting at 9:15 a.m. for the Board of Equalization.

BOARD OF EQUALIZATION MEETING: Chairman Randy Dean called the Board of Equalization meeting to order at 9:15 a.m. with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Dean informed the public about the location of the posted Open Meetings Act.

Assessor Kristi Korell joined the Board to make recommendations on applications for tax exemptions on real and personal property. Korell explained that every four years nonprofits must reapply for tax exemptions. There were three new ones this year. She is recommending that the Board approve all of the applications.

The Board will hold a public hearing to receive public comments on the applications for tax exemptions on real and personal property March 11, 2024, at 9:15 a.m.

Chairman Dean adjourned the Board of Equalization meeting at 9:21 a.m.

BOARD OF COMMISSIONERS MEETING: (Reconvened)

Chairman Gans reconvened the Board of Commissioners meeting at 9:21 a.m.

A motion was made by Fritsche, seconded by Dean, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) accounts payable claims in the amount of \$480,381.01, 3) Resolution No. 1508, Book 24, Page 15, to Add New Solor Regulations to Zoning Plan, 4) One-Year Audit Engagement Letter with Donald D. Wilson, CPA. Roll call: Ayes: Gans, Dean, Fritsche.

The Board discussed county road maintenance and crack sealing. Gans had some leads on suppliers, but the Board needs to decide which roads need repaired the worst.

A motion was made by Dean, seconded by Fritsche, to set March 11, 2024 at 9:30 a.m. as the date and time to open bids for county road maintenance and crack sealing on approximately 30 miles using ARPA funds. Roll Call: Ayes: Gans, Dean, Fritsche.

A motion was made by Fritsche, seconded by Dean, to recess the regular meeting and enter into a public hearing at 9:45 a.m. to receive public comments on the One and Six-Year Road Plan. Roll Call: Ayes: Gans, Dean, Fritsche.

Kevin Petross with Miller & Associates joined the Board as they reviewed a map of the roads involved in the plan. There are six locations on the plan.

A motion was made by Dean, seconded by Fritsche, to adjourn the public hearing at 9:50 a.m. and reconvene the regular meeting. Roll Call: Ayes: Gans, Dean, Fritsche.

A motion was made by Dean, seconded by Fritsche, to adopt Resolution No. 1506, Book 24, Page 13 to Adopt the 2024 One and Six-Year Road Plan, with the deletion of Project C73(188). Roll call: Ayes: Gans, Dean, Fritsche.

Kent Meyers with Frenchman Valley Co-op joined the Board to discuss supplying the County with fuel. FVC will write off the County's past due amount, and will provide fuel to the County at .13 below pump price using the pump cards.

A motion was made by Dean, seconded by Fritsche, to set February 26, 2024, at 9:30 a.m. to review informal bids for a backhoe. Roll call: Ayes: Gans, Dean, Fritsche.

The Board considered a request for financial assistance with burial costs from Herrmann-Jones Funeral Home.

A motion was made by Fritsche, seconded by Dean, to decline the request. Roll call: Ayes: Gans, Dean, Fritsche.
