BOARD OF COMMISSIONERS AND BOARD OF EQUALIZATION MEETINGS February 26, 2024

The Red Willow County Board of Commissioners and the Board of Equalization met in the Commissioners' Room in the courthouse on February 26, 2024. A notice of the meetings was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Ted Gans called the Board of Commissioners meeting to order with the following members present: Commissioners Ted Gans, Randy Dean and Charles Fritsche. Gans informed the public about the location of the posted Open Meetings Act.

A motion was made by Fritsche, seconded by Dean, to approve the agendas as presented. Roll call: Ayes: Gans, Dean, Fritsche.

Chairman Gans offered the floor for Citizens' Comments. No one was present.

A motion was made by Dean, seconded by Fritsche, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) accounts payable and payroll claims in the amount of \$378,250.66, 3) review backhoe bids at 10:30 a.m. rather than 9:30 a.m., 4) Oversized Load Permit for Star House Moving, 5) reappoint Kevin Potthoff to Health Board, term to expire January 31, 2027. Roll call: Ayes: Gans, Dean, Fritsche.

Notices from the Nebraska Department of Transportation regarding road construction in Red Willow County were reviewed and placed on file.

The NIRMA's annual report and the Sheriff's monthly revenue report were reviewed and placed on file.

There were no issues for the Board of Equalization.

A motion was made by Dean, seconded by Fritsche, to recess the regular meeting and enter into a public hearing at 9:30 a.m. to receive public comments on the Application for Conditional Use Permit submitted by Haag Land and Cattle Large Feedlot Operation Waste Storage Facility, located in pt of N/2 of Section 30, Range 2, Township 26 West of the 6th P.M., Red Willow County, Nebraska. Roll call: Ayes: Gans, Dean, Fritsche.

Craig Bennett, Zoning Administrator, joined the hearing via phone and confirmed that the Planning & Zoning Committee recommended approval of this conditional use permit. The project follows the County's zoning regulations and the impact easements that are required for Class 1 LFOs.

Myrna Haag shared concerns about the livestock expansions. She owns land around the proposed projects. Her family is concerned about the odor, insects, rodents, increased traffic, Dean asked Buck Haag how much traffic this expansion will cause. Haag wondered what the County's plans are for the Bartley Road.

A motion was made by Dean, seconded by Fritsche, to adjourn the public hearing at 9:50 a.m. and reconvene the regular meeting. Roll call: Ayes: Gans, Dean, Fritsche.

A motion was made by Dean, seconded by Fritsche, to adopt Resolution No. 1509, Book 24, Page 16, to approve the application for Conditional Use Permit submitted by Haag Land and Cattle Large Feedlot Operation Waste Storage Facility, located in pt of N/2 of Section 30, Range 2, Township 26 West of the 6th P.M., Red Willow County, Nebraska. Roll call: Ayes: Gans, Dean, Fritsche.

A motion was made by Dean, seconded by Fritsche, to recess the regular meeting and enter into a public hearing at 9:55 a.m. to receive public comments on the Application for Conditional Use Permit submitted by Uhrich & Brown LTD Large Feedlot Operation Waste Storage Facility Holding Ponds, pt NE/4 of Section 29 Township 4 Range 29 West of the 6th P.M., Red Willow County, Nebraska. Roll call: Ayes: Gans, Dean, Fritsche.

Travis Casperson, Dave Kuchera and Ami Hauxwell were present to explain that these holding ponds are for run-off from the dairy, which will be pumped to the new location.

A motion was made by Fritsche, seconded by Dean, to adjourn the public hearing at 10:00 a.m. and reconvene the regular meeting. Roll call: Ayes: Gans, Dean, Fritsche.

A motion was made by Dean, seconded by Fritsche, to adopt Resolution No. 1510, Book 24, Page 17, to approve the application for Conditional Use Permit submitted by Uhrich & Brown LTD Large Feedlot Operation Waste Storage Facility Holding Ponds, pt NE/4 of Section 29 Township 4 Range 29 West of the 6th P.M., Red Willow County, Nebraska. Roll call: Ayes: Gans, Dean, Fritsche.

A motion was made by Fritsche, seconded by Dean, to recess the regular meeting and enter into a public hearing at 10:00 a.m. to receive public comments on the Application for Conditional Use Permit submitted by Ruggles Farms, Inc. Large Feedlot Operation Waste Storage Facility Expansion, pt NE/4 Section 11 Township 3 Range 29, pt NW/4 Section 12 Township 3 Range 29 West of the 6th P.M., Red Willow County, Nebraska. Roll call: Ayes: Gans, Dean, Fritsche.

Travis Casperson presented arial photos of the location and explained the size of the storage ponds.

A motion was made by Fritsche, seconded by Dean, to adjourn the public hearing at 10:10 a.m. and reconvene the regular meeting. Roll call: Ayes: Gans, Dean, Fritsche.

A motion was made by Dean, seconded by Fritsche, to adopt Resolution No. 1511, Book 24, Page 18, to approve the application for Conditional Use Permit submitted by Ruggles Farms, Inc. Large Feedlot Operation Waste Storage Facility Expansion, pt NE/4 Section 11 Township 3 Range 29, pt NW/4 Section 12 Township 3 Range 29 West of the 6th P.M., Red Willow County, Nebraska. Roll call: Ayes: Gans, Dean, Fritsche.

Charlie McPherson and Amanda Engell with the McCook Economic Development Corporation joined the Board to present their annual report. The housing projects are progressing well. They are building three duplexes with attached garages which will be for sale when finished. The single-family home project on North Pointe is also moving forward.

The MEDC also assisted with the transfer of a day care center, and with residential housing for the hospital. They have assisted with building single family homes in McCook, Benkelman, and Cambridge, and are looking at Indianola next.

McPherson and Engell are looking for 2024/2025 projects.

The Board reviewed informal bids for a backhoe. Dean presented 19 bids. The Board discussed a backhoe with Greg from Nebraska Machinery. His bid is a 2017 Cat for \$90,000, which is the only one bid with a warranty.

A motion was made by Dean, seconded by Fritsche, to purchase the 2017 Cat for \$90,000 from NMC pending inspection using ARPA funds. Roll call: Ayes: Gans, Dean, Fritsche.

Sheriff Kevin Darling and Jail Administrator Dee Schilz joined the Board to discuss rust mitigation at the jail facility. The "stainless steel" is rusting badly, and the company who provided the materials has gone out of business.

A motion was made by Dean, seconded by Fritsche, to declare the rust issue at the jail an emergency item and direct the Sheriff to address the problem. ARPA funds will be available for this emergency. Roll call: Ayes: Gans, Dean, Fritsche.
