

# Red Willow County Board Minutes



BOARD OF COMMISSIONERS MEETING

December 9, 2019

The Red Willow County Board of Commissioners met in the Commissioners' Room in the courthouse on December 9, 2019. A notice of the meeting was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Earl McNutt called the Board of Commissioners meeting to order with the following members present: Commissioners Earl McNutt, Steve Downer and Cayla Richards. McNutt informed the public about the location of the posted Open Meetings Act.

A motion was made by Richards, seconded by Downer, to approve the agendas as presented. Roll call: Ayes: McNutt, Downer, Richards.

Chairman McNutt offered the floor for Citizens' Comments. Assessor Kristi Korell and Custodian Greg Holthus spoke to the Board about the County car.

Treasurer Sue Wesch presented a report of Collected and Uncollected Distress Warrants. There was one distress warrant issued for a total of \$51.22.

A motion was made by Downer, seconded by Richards, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) accounts payable claims in the amount of \$128,091.05, 3) adopt Resolution No. 1376 Book 22 Page 56 to transfer \$24,744.37 from Buy-Back Fund 0650 to Road Fund 0300, 4) adopt Resolution No. 1377 Book 22 Page 57 to transfer \$11,750.00 from General Fund 0100 to Child Support Attorney Incentive Fund 0985, 5) approve changes to Pledged Securities for County Treasurer, 6) approve use of liquor at the following events at the Fairgrounds in December: Barger Craft Show, Ormesher Wedding, Tri-State Livestock Christmas, Carfield Christmas, Quigley Christmas, Hackney Christmas, Ruppert Christmas, Jordan Gatsby Party. A Notice of Meeting from the Veterans Service Board was reviewed and placed on file.

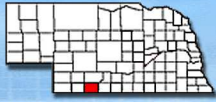
The Clerk of District Court's Monthly Revenue Report was reviewed and placed on file.
