BOARD OF COMMISSIONERS MEETING

July 27, 2020

The Red Willow County Board of Commissioners met in the Commissioners' Room in the courthouse on July 27, 2020. A notice of the meeting was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Earl McNutt called the Board of Commissioners meeting to order with the following members present: Commissioners Earl McNutt, Steve Downer and Cayla Richards. McNutt informed the public about the location of the posted Open Meetings Act.

A motion was made by Richards, seconded by Downer, to approve the agenda as presented. Roll call: Ayes: McNutt, Downer, Richards.

Chairman McNutt offered the floor for Citizens' Comments. No one was present.

The Board reviewed the previous minutes and the claims.

A motion was made by Downer, seconded by Richards, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) accounts payable and payroll claims in the amount of \$279,572.89, 3) reappoint Greg Hoffman to Planning Commission, term to expire April 30, 2023, 4) authorize Chairman's signature on Notice to Proceed for Figgins Construction Co., 5) authorize Chairman's signature on Interlocal Agreement with Furnas County for Veterans Service Officer, 6) Authorize Chairman's Signature on Resolution No. 1391, Book 22, Page 71 to Close Out the Kiplinger Mural Fund 4025. Roll call: Ayes: McNutt, Downer, Richards.

The Board reviewed a letter from Donna Goad with Domestic Abuse/Sexual Assault Services requesting continued support for the 2020/2021 fiscal year.

A motion was made by Richards, seconded by Downer, to approve continued support to Domestic Abuse/Sexual Assault Services in the amount of \$10,096.00. Roll call: Ayes: McNutt, Downer, Richards.

Trent Jollensten brought his concerns about the ownership of a mobile home before the Board. He explained that the title to the mobile home is not in his name and has never been in his name. Deputy Treasurer Crystal Dack joined the Board to advise how he can get a title to the mobile home.

The Board worked on budgets.
