BOARD OF COMMISSIONERS MEETING

September 21, 2020

The Red Willow County Board of Commissioners met in the Commissioners' Room in the courthouse on September 21, 2020. A notice of the meeting was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Earl McNutt called the Board of Commissioners meeting to order with the following members present: Commissioners Earl McNutt, Steve Downer and Cayla Richards. McNutt informed the public about the location of the posted Open Meetings Act.

A motion was made by Downer, seconded by Richards, to approve the agenda as presented. Roll call: Ayes: McNutt, Downer, Richards.

Chairman McNutt offered the floor for Citizens' Comments. No one was present.

A motion was made by Richards, seconded by Downer, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) there were no claims, 3) move accounts payable claims to October 19, 2020 due to Columbus Day, 4) authorize Chairman's signature on liquor license for Broken Arrow Cellars LLC, 5) authorize Chairman's signature on Interlocal Agreement with the City of Indianola for Law Enforcement, 6) authorize Chairman's signature on Annual SSAR Certification. Roll call: Ayes: McNutt, Downer, Richards.

Sue Wesch, Treasurer, presented Resolution No. 1409, Book 22, Page 89, to Assign County Sales Certificates that she designated by numbers 1-2020 to 36-2020 for delinquent taxes on properties that were not sold at a public tax sale for want of bidders. She said the certificates were ready for the Board-appointed attorney to begin foreclosure proceedings. A motion was made by Downer, seconded by Richards, to adopt Resolution No. 1409, Book 22, Page 89, to Assign County Sales Certificates. Roll call: Ayes: McNutt, Downer, Richards.

Kristi Korell, Assessor, joined the Board to request approval of contract for Pritchard & Abbott for oil appraisals.

A motion was made by Downer, seconded by Richards, to approve the contract for Pritchard & Abbott for oil appraisal services. Roll call: Ayes: McNutt, Downer, Richards.

The following correspondence was reviewed and placed on file: Nebraska Department of Environment and Energy – Modification and Approval to N.A. Timmerman Concentrated Feeding Operation.

The following reports were reviewed and placed on file: 1) Clerk's Monthly Revenue Report, 2) COVID-19 Update from SWNPHD.
