BOARD OF COMMISSIONERS AND BOARD OF EQUALIZATION MEETINGS

October 19, 2020

The Red Willow County Board of Commissioners and the Board of Equalization met in the Commissioners' Room in the courthouse on October 19, 2020. A notice of the meetings was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, posted on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Vice Chairman Steve Downer called the Board of Commissioners meeting to order with the following members present: Steve Downer and Cayla Richards. Earl McNutt was absent. Downer informed the public about the location of the posted Open Meetings Act.

A motion was made by Richards, seconded by Downer, to approve the agendas as presented. Roll call: Ayes: Downer, Richards. Absent: McNutt.

Vice Chairman Downer offered the floor for citizens' comments. No one was present.

The Board reviewed the minutes from the previous meeting and the accounts payable claims.

A motion was made by Richards, seconded by Downer, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners meeting, 2) accounts payable claims in the amount of \$263,563.32. Roll call: Ayes: Downer, Richards. Absent: McNutt.

Downer reconvened the Board of Commissioners meeting at 9:18 a.m.

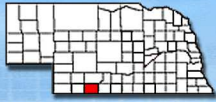
The Fall Newsletter from DASAS and the Clerk's monthly revenue report were reviewed and placed on file.
