



# Red Willow County Board Minutes



BOARD OF COMMISSIONERS MEETING

November 16, 2020

The Red Willow County Board of Commissioners met in the Commissioners' Room in the courthouse on November 16, 2020. A notice of the meeting was published in the McCook Gazette and posted on the County's website. The agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Earl McNutt called the Board of Commissioners meeting to order with the following members present: Commissioners Earl McNutt, Steve Downer and Cayla Richards. McNutt informed the public about the location of the posted Open Meetings Act.

A motion was made by Downer, seconded by Richards, to approve the agenda as presented. Roll call: Ayes: McNutt, Downer, Richards.

Chairman McNutt offered the floor for Citizens' Comments. No one was present.

A motion was made by Richards, seconded by Downer, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners meeting and Board of Equalization, 2) miscellaneous accounts payable claims in the amount of \$29,967.72. Dee Schilz, Jail Administrator, joined the Board to report on the status of the jail and the inmates in lieu of an in-person inspection. They had all the inmates tested for Covid last week and all of them came back negative. Everything is going well.
