



# Red Willow County Board Minutes



## BOARD OF COMMISSIONERS AND BOARD OF EQUALIZATION MEETINGS

March 22, 2021

The Red Willow County Board of Commissioners and the Board of Equalization met in the Commissioners' Room in the courthouse on March 22, 2021. A notice of the meetings was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, posted on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Earl McNutt called the Board of Commissioners meeting to order with the following members present: Earl McNutt, Cayla Richards and Randy Dean. McNutt informed the public about the location of the posted Open Meetings Act.

Chairman McNutt offered the floor for citizens' comments. No one was present.

The Board reviewed the minutes from the previous meeting and the miscellaneous accounts payable and payroll claims.

A motion was made by Dean, seconded by McNutt, to approve the minutes from the previous Board of Commissioners meeting. Roll Call: Ayes: McNutt, Dean. Abstain: Richards.

A motion was made by Richards, seconded by Dean, to approve the remaining items on the consent agenda: 2) miscellaneous accounts payable and payroll claims in the amount of \$285,742.84, 3) authorize Chairman's signature on Oversized Load Permit for Star House Moving. Roll call: Ayes: McNutt, Richards, Dean.

### BOARD OF EQUALIZATION MEETING:

Chairman Cayla Richards called the Board of Equalization meeting to order at 9:15 a.m. with the following members present: Commissioners Cayla Richards, Earl McNutt and Randy Dean. Richards informed the public about the location of the posted Open Meetings Act.

Crystal Dack, Treasurer, presented a motor vehicle exemption for Community Hospital.

A motion was made by McNutt, seconded by Dean, to approve the motor vehicle tax exemption for Community Hospital. Roll Call: Ayes: Richards, McNutt, Dean.

Dack also presented a tax roll correction for the Tax Year 2018 and one tax roll correction for the Tax Year 2020. A motion was made by Dean, seconded by McNutt, to approve tax Roll Correction No. 36 which increased the tax rolls by \$1,637.58 and Tax Roll Correction No. 5 which increased the tax rolls by \$26.64.
