BOARD OF COMMISSIONERS MEETING

June 14, 2021

The Red Willow County Board of Commissioners met in the Commissioners' Room in the courthouse on June 14, 2021. A notice of the meeting was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Earl McNutt called the Board of Commissioners meeting to order with the following members present: Commissioners Earl McNutt, Cayla Richards and Randy Dean. McNutt informed the public about the location of the posted Open Meetings Act.

A motion was made by Richards, seconded by Dean, to approve the agenda as presented. Roll call: Ayes: McNutt, Richards, Dean.

Chairman McNutt offered the floor for Citizens' Comments. John Webster with Murphy Tractor was present to speak to the Commissioners. They are will be demonstrating a road grader for the County on Tuesday June 15, 2021.

Kathy Haas and George Young with Family Resources joined the Board to present their annual report. They have been providing free services to families in southwestern Nebraska since 1996. They have a history of serving a large number of individuals on a minimal budget.

A motion was made by Richards, seconded by Dean, to continue support of Family Resources in the amount of \$6,500.00 for the 2021/2022 fiscal year. Roll call: Ayes: McNutt, Richards, Dean.

A motion was made by Dean, seconded by Richards, to enter into a public hearing at 10:00 a.m. to receive comments regarding vacation of county Drive 717 right-of-way in section 18-3-27. Roll Call: Ayes: McNutt, Richards, Dean

Scott Clifford, County Surveyor, Calvin & Brenda Grube, Mike Malleck and Alex Haag were present for the public hearing. Scott Clifford did look at the original road right of way. There is no need for the old right of way to be on record as an existing right of way. The land will revert back to the existing property owners.

A motion was made by Richards, seconded by Dean to adjourn from the public hearing at 10:23 a.m. Roll Call: Ayes: McNutt, Richards, Dean.

A motion was made by Dean, seconded by Richards, to vacate everything outside of the current road right of way in Government Lots 5 & 9 on Drive 717 in section 18-3-27. Roll Call: Ayes: McNutt, Richards, Dean.

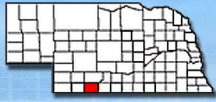
