

# Red Willow County Board Minutes



## BOARD OF COMMISSIONERS AND BOARD OF EQUALIZATION MEETINGS

July 26, 2021

The Red Willow County Board of Commissioners and the Board of Equalization met in the Commissioners' Room in the courthouse on July 26, 2021. A notice of the meetings was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, posted on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Earl McNutt called the Board of Commissioners meeting to order with the following members present: Earl McNutt and Randy Dean. Cayla Richards was absent. McNutt informed the public about the location of the posted Open Meetings Act.

A motion was made by Dean, seconded by McNutt, to approve the agendas as presented. Roll call: Ayes: McNutt, Dean. Absent: Richards.

Chairman McNutt offered the floor for citizens' comments. No one was present.

The Board reviewed the minutes from the previous meetings and the payroll claims.

A motion was made by Dean, seconded by McNutt, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) payroll claims in the amount of \$259,937.32, 3) County Roadway Occupancy Agreement for Black Hills Energy. Roll call: Ayes: McNutt, Dean. Absent: Richards.

McNutt recessed the Commissioners' meeting at 9:15 a.m. for the Board of Equalization.

### BOARD OF EQUALIZATION MEETING:

Vice Chairman Earl McNutt called the Board of Equalization meeting to order at 9:15 a.m. with the following members present: Commissioners Earl McNutt and Randy Dean. Cayla Richards was absent. McNutt informed the public about the location of the posted Open Meetings Act.

Becky Loop, Deputy Assessor, joined the Board to present the Assessor's three-year plan of assessment. Loop also reported on County cemeteries. There are 19 cemeteries, including those in the city of McCook that had no change of ownership or use. Loop also presented applications requesting extensions on three Homestead Exemptions.

A motion was made by Dean, seconded by McNutt, to grant extensions on the Homestead Exemption applications for Beverly Rhea, Dale & Gloria Cotton and David Wilson. Roll Call: Ayes: McNutt, Dean. Absent: Richards.

The Board read a thank-you note from Tri Valley Transportation.

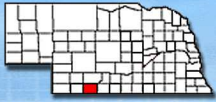
