BOARD OF COMMISSIONERS MEETING

August 9, 2021

The Red Willow County Board of Commissioners met in the Commissioners' Room in the courthouse on August 9, 2021. A notice of the meeting was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Earl McNutt called the Board of Commissioners meeting to order with the following members present: Commissioners Earl McNutt, Cayla Richards and Randy Dean. McNutt informed the public about the location of the posted Open Meetings Act.

A motion was made by Dean, seconded by Richards, to approve the agenda as presented. Roll call: Ayes: McNutt, Richards, Dean.

Chairman McNutt offered the floor for Citizens' Comments. No one was present.

The Board reviewed the minutes from the previous meeting and the accounts payable claims.

A motion was made by Richards, seconded by Dean, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) accounts payable claims in the amount of \$290,065.20. Roll call: Ayes: McNutt, Richards, Dean.

Lorena Parish with Bridge of Hope called to present their annual report and to request support for the 2021/2022 fiscal year. A motion was made by Richards, seconded by Dean, to contribute \$3,500.00 to Bridge of Hope for the fiscal year 2021/2022, which is up from \$2,000.00 in previous years. Dan Miller joined the Board to work on the County budgets.

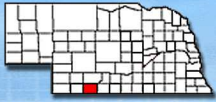
The Board performed the quarterly jail inspection. Everything was found to be satisfactory.
