

Red Willow County Board Minutes



BOARD OF COMMISSIONERS MEETING

September 27, 2021

The Red Willow County Board of Commissioners met in the Commissioners' Room in the courthouse on September 27, 2021. A notice of the meeting was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Earl McNutt called the Board of Commissioners meeting to order with the following members present: Commissioners Earl McNutt, Cayla Richards and Randy Dean. McNutt informed the public about the location of the posted Open Meetings Act.

A motion was made by Richards, seconded by Dean, to approve the agenda as presented. Roll call: Ayes: McNutt, Richards, Dean.

Chairman McNutt offered the floor for Citizens' Comments. No one was present.

The Board reviewed the minutes from the previous meeting and the miscellaneous accounts payable and payroll claims.

Crystal Dack, Treasurer, Lori O'Dea, District Court Clerk, and Paul Wood, Attorney, joined the meeting to discuss the process of foreclosure on properties that were not sold at a public tax sale for want of bidders. Dack needs to get them to Wood six months before they are expired. Once Paul files them Crystal doesn't have to do anymore with them.

Dack then presented 51 certificates to Assign County Sales Certificates designated for delinquent taxes on properties that were not sold at a public tax sale for want of bidders. She said the certificates were ready for the Attorney to begin foreclosure proceedings.

Heidi Wheeler, Assistant Director with Southwest Nebraska Public Health Department presented the annual report for 2019/2020. She also gave the Board their community health assessment.

Penny Cooper, Deputy Clerk, informed the Board that the Secretary of State requested all election offices switch to the .gov domain. Ed Knott with Applied Connective sent a proposal including costs. He said it would be beneficial if all county offices made the change. .gov is protected by Homeland Security's technology department. Randy Dean offered to get a second quote.

A motion was made by Richards, seconded by Dean, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) miscellaneous accounts payable and payroll claims in the amount of \$395,388.86. Roll call: Ayes: McNutt, Richards, Dean.

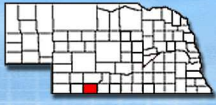
