BOARD OF COMMISSIONERS MEETING

October 25, 2021

The Red Willow County Board of Commissioners met in the Commissioners' Room in the courthouse on October 25, 2021. A notice of the meeting was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Earl McNutt called the Board of Commissioners meeting to order with the following members present: Commissioners Earl McNutt, Cayla Richards and Randy Dean. McNutt informed the public about the location of the posted Open Meetings Act.

A motion was made by Richards, seconded by Dean to approve the agenda as presented. Roll call: Ayes: McNutt, Richards, Dean.

Chairman McNutt offered the floor for Citizens' Comments. No one was present.

The Board reviewed the minutes from the previous meeting and the miscellaneous accounts payable and payroll claims.

A motion was made by Dean, seconded by Richards, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) miscellaneous accounts payable and payroll claims in the amount of \$303,416.92, 3) participation in Opioid Litigation Settlements. Roll call: Ayes: McNutt, Richards, Dean.

Nathaniel Mustion, City Attorney, joined the Board to talk about jail time for nonpayment of fines. He prosecutes people for breaking city ordinances. He has been allowed to have people set out their fines in jail if they haven't paid their fine. A Judge wanted him to make sure she wasn't overstepping her bounds by putting them in jail. No action was taken at this time.
