

# Red Willow County Board Minutes



BOARD OF COMMISSIONERS MEETING

November 8, 2021

The Red Willow County Board of Commissioners met in the Commissioners' Room in the courthouse on November 8, 2021. A notice of the meeting was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Earl McNutt called the Board of Commissioners meeting to order with the following members present: Commissioners Earl McNutt, Cayla Richards and Randy Dean. McNutt informed the public about the location of the posted Open Meetings Act.

A motion was made by Dean, seconded by Richards, to approve the agenda as presented. Roll call: Ayes: McNutt, Richards, Dean.

Chairman McNutt offered the floor for Citizens' Comments. Several leadership members were present to observe the meeting.

The Board reviewed the minutes from the previous meeting and the accounts payable claims.

A motion was made by Richards, seconded by Dean, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) accounts payable claims in the amount of \$592,342.73, 3) changes to Pledged Securities for County Treasurer, 4) County Roadway Occupancy Agreement for McCook Public Power District. Roll call: Ayes: McNutt, Richards, Dean.

Kristi Korell, Assessor, joined the Board to present a contract with Central Plains Valuation for Commercial Maintenance for Board's approval. Their contract is \$125.00 per hour billed on a monthly basis.

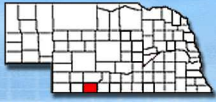
