BOARD OF COMMISSIONERS MEETING

November 22, 2021

The Red Willow County Board of Commissioners met in the Commissioners' Room in the courthouse on November 22, 2021. A notice of the meeting was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Earl McNutt called the Board of Commissioners meeting to order with the following members present: Commissioners Earl McNutt, Cayla Richards and Randy Dean. McNutt informed the public about the location of the posted Open Meetings Act.

A motion was made by Richards, seconded by Dean, to approve the agenda as presented. Roll call: Ayes: McNutt, Richards, Dean.

Chairman McNutt offered the floor for Citizens' Comments. No one was present.

The Board reviewed the minutes from the previous meeting and the miscellaneous accounts payable and payroll claims.

A motion was made by Richards, seconded by Dean, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) miscellaneous accounts payable and payroll claims in the amount of \$278,671.58. Roll call: Ayes: McNutt, Richards, Dean.

Nathaniel Mustion, City Attorney, joined the Board to talk about jail time for nonpayment of fines. He prosecutes people for breaking city ordinances. He has been allowed to have people sit out their fines in jail if they haven't paid their fine. A Judge wanted him to make sure she wasn't overstepping her bounds by putting them in jail. Paul Wood, County Attorney gave the advice to charge the City the going rate of what Red Willow County charges to house prisoners which is \$45.00 a day. Dean is concerned about the jail being full and not having enough room to house extras. A motion was made by Dean, seconded by Richards, to have Wood draw up a contract in regards to housing prisoners for the City and all other entities for sitting out fines. A check from EMC Insurance for the County's safety record dividend of \$5,418.00 was reviewed and placed on file.
