BOARD OF COMMISSIONERS MEETING

December 27, 2021

The Red Willow County Board of Commissioners met in the Commissioners' Room in the courthouse on December 27, 2021. A notice of the meeting was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Earl McNutt called the Board of Commissioners meeting to order with the following members present: Commissioners Earl McNutt, Cayla Richards and Randy Dean. McNutt informed the public about the location of the posted Open Meetings Act.

A motion was made by Richards, seconded by Dean, to approve the agenda as presented. Roll call: Ayes: McNutt, Richards, Dean.

Chairman McNutt offered the floor for Citizens' Comments. Dale Cotton was present. Dale had some concerns about the discussion on closing the road that was on the agenda last week. He says the roads and easements are needed. He spoke about tourism also.

The Board reviewed the minutes from the previous meeting and the accounts payable and payroll claims.
