BOARD OF COMMISSIONERS MEETING

April 25, 2022

The Red Willow County Board of Commissioners met in the Commissioners' Room in the courthouse on April 25, 2022. A notice of the meeting was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Earl McNutt called the Board of Commissioners meeting to order with the following members present: Commissioners Earl McNutt, Randy Dean and Cayla Richards. McNutt informed the public about the location of the posted Open Meetings Act.

A motion was made by Dean, seconded by Richards, to approve the agenda as presented. Roll call: Ayes: McNutt, Dean, Richards.

Chairman McNutt offered the floor for Citizens' Comments. No one was present.

The Board reviewed the minutes from the previous meeting and the miscellaneous accounts payable and payroll claims.

A motion was made by Richards, seconded by Dean, to approve the following items on the consent agenda: 1) minutes from the previous Board of Commissioners and Board of Equalization meetings, 2) miscellaneous accounts payable and payroll claims in the amount of \$346,756.36, 3) Special Liquor License for Jeremy Loomis, 4) Addendum to Contract with Consolidated Correctional Foodservice, 5) Letter of Support for the Western Republican River Basin Riparian Habitat Improvement Project. The Board performed the quarterly jail inspection. Everything was found to be satisfactory.

Amber Anderson, Brad Swiggert and Mitch Lyster from the Olson Group joined to Board to update them on the County employee insurance. They feel it would be a benefit to the County to change third part administrators from Regional Care Inc. to Lucent Health. A motion was made by Dean, seconded by Richards to change the third-party administrator from Regional Care Inc. to Lucent and change the prescription insurance from WellDyne to Magellan.
