

Red Willow County Board Minutes



BOARD OF COMMISSIONERS MEETING

November 28, 2022

The Red Willow County Board of Commissioners met in the Commissioners' Room in the courthouse on November 28, 2022. A notice of the meeting was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Earl McNutt called the Board of Commissioners meeting to order with the following members present: Commissioners Earl McNutt, Randy Dean and Cayla Richards. McNutt informed the public about the location of the posted Open Meetings Act.

A motion was made by Richards seconded by Dean, to approve the agenda as presented. Roll call: Ayes: McNutt, Dean, Richards.

Chairman McNutt offered the floor for Citizens' Comments. Ted Gans was present.

The Board reviewed the minutes from the previous meeting and the miscellaneous accounts payable and payroll claims.

A motion was made by Dean, seconded by McNutt, to approve the minutes from the previous Board of Commissioners and Board of Equalization meetings. Roll call: Ayes: McNutt, Dean. Abstain: Richards.

A motion was made by Richards, seconded by Dean, to approve the remaining items on the consent agenda: 2) miscellaneous accounts payable and payroll claims in the amount of \$436,071.50, 3) Board signatures on Workforce Housing Commitment Form. Roll call: Ayes: McNutt, Dean, Richards.

Bids for motor grader cutting edges were opened at 9:30 a.m. with Brett Brown of Nebraska Machinery Company present. Bids for 30,000 lbs. of grader blades of ½" x 6" x 8' and 15,000 lbs. of grader blades of ½" x 8" x 8' were as follows: 1) Midwest Services & Sales, Schuyler - \$8.13/ft. for the 6" blades and, \$11.63/ft. for the 8" blades for a total of \$42,356.18, 2) Nebraska Machinery Company - \$7.18/ft. for 430 pieces of the 6" blades and \$9.86/ft. for the 8" blades for a total bid of 36,528.45. A motion was made by Dean, seconded by Richards, to accept the bid from Nebraska Machinery Company for one load of grader blades for a cost of \$7.18 per ft. for the ½" x 6" x 8' and \$9.86 for the ½" x 8" x 8' blades for a total bid of \$36,528.45. Roll call: Ayes: McNutt, Richards, Dean.

The Sheriff's monthly revenue report was reviewed and placed on file.

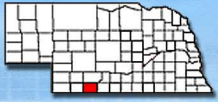
