BOARD OF COMMISSIONERS MEETING

December 12, 2022

The Red Willow County Board of Commissioners met in the Commissioners' Room in the courthouse on December 12, 2022. A notice of the meeting was published in the McCook Gazette and posted on the County's website. The combined agenda was e-mailed to each commissioner and the news media, uploaded on the County's website, and kept current and available to the public at the County Clerk's Office.

At 9:00 a.m. Chairman Earl McNutt called the Board of Commissioners meeting to order with the following members present: Commissioners Earl McNutt, Randy Dean and Cayla Richards. McNutt informed the public about the location of the posted Open Meetings Act.

A motion was made by Richards, seconded by Dean, to approve the agenda as presented. Roll call: Ayes: McNutt, Dean, Richards.

Chairman McNutt offered the floor for Citizens' Comments. Ron Soden was present. Soden had some questions and concerns about the Solar Farm that wants to come to Red Willow County.

The Board reviewed the minutes from the previous meeting and the accounts payable claims.

Crystal Dack, Treasurer, presented an additional Collected and Uncollected Distress Warrant.

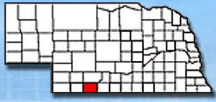
